

#### It All Starts with a Scribble: Emergent Writing Strategies and Tools

**Description:** Many of us work with students who write via non-traditional modalities. With the introduction of various assistive technologies, apps and lo-tech writing supports, family and staff often miss the emerging steps of scribbling and drawing. We put an adapted keyboard in front of our students with complex learning needs or provide a lo-tech alternative pencil and immediately expect these students to write their name and a syntactically correct sentence. Instead, we need to back off of writing conventions and allow our students to explore the writing tool/s of their future.

During this webinar, we will share with you strategies and tools to encourage, support, and provide emergent writing opportunities for students with complex learning needs to

experience the beginning stages of putting ideas to print; encouraging meaningful and active involvement in the acts of scribbling and drawing.

Objectives: As a result of attending this webinar, participants will be able to:

- 1. locate a minimum of 2 apps and 2 products to support scribbling for children/students with complex learning needs
- 2. identify a writing scale that recognizes the value of scribbling and drawing

**Description:** The Comprehensive Literacy State Development (CLSD) grant provides literacy coaches and resources to support the implementation of ten literacy evidence-based practices for middle school and high school.

On the surface, many of these evidence-based practices may seem focused on students in the more typical general education population; however, digging deeper, there are ways in

which these evidence-based practices can be, and often already are, implemented in a way that benefits all students, even those with the most unique needs. Furthermore, connections can also be made between the ten literacy evidence-based practices of the CLSD grant and the Center for Exceptional Children's (CEC) four "pillars" of High Leverage Practices (HLP) for special education educators.

This session will share how teachers in one district have found ways to embrace evidence-based practices in a way that fits the needs of their population, as well as an opportunity for participants to share their own experiences with evidence-based and high leverage practices.
